Student Record WebViewer allows your users to view CIMS® III student data using their web browser. It retrieves your data directly from the IBM AS/400 for real time accuracy. Security is handled through a separate Access database and the **WebViewer** administration screen. **Student Record WebViewer** also accommodates teachers as users. It incorporates security that allows teachers to view only their own student's information and also includes the ability to log the activities of a user. The system administrator assigns the user member and authority and you are ready to begin 'surfing' your student data.

In order to use our product you need to have the following installed:

- IBM AS/400 V4R5 running NCS PEARSON CIMS® III Software
- Windows 2000 Server running IIS 5.00, server patches must be up to date
- IBM Client Access Express ODBC Driver installed on the Windows Server
- Macromedia's Cold Fusion 5.0 or higher (Professional or Enterprise version) also installed on the Windows Server (version 4.5 will also work)

We offer installation support for thirty days from the date of purchase. In addition, you may purchase an annual subscription that provides support for one year that includes product maintenance, feature enhancement updates, non-toll free telephone and e-mail support. The annual subscription prices quoted are for purchases made at the time of the original sale. Special terms apply to purchases made after that time.
